





What type of taxpayer are you?

Business	You are a Business if you have a Corporation, Limited Liability Corporation, or a sole-proprietorship. Businesses identify using a Federal Employer Identification Number or for Sole-Proprietorships, a Social Security Number or ITIN.
Commercial Vehicle Carrier	You are a Commercial Vehicle Carrier if you are registered for Weight Distance Tax, IFTA, or IRP.
Individual	You are an Individual if you have filed a Personal Income Tax return in New Mexico. Individuals identify themselves using a Social Security Number or Individual Taxpayer Identification Number.
Levy	You are an Employer or Financial Institution providing payment towards an existing Wage Levy, Bank Levy or 3rd Party Levy.



Credit Card (Additional Fee)	Paying by credit card will immediately affect your balance. Any liability on your account can be immediately resolved by a credit card payment. A convenience fee of 2.40% with a minimum of \$1.55 is applied when using a credit card. The State of New Mexico uses this fee, calculated on the transaction amount, to pay charges from the credit card companies. There is no charge for an electronic check.
E-Check (FREE)	E-Checks can take multiple days for payments to be resolved due to bank processing times. Your payments will be shown as pending, not as completed. Until the check has been cleared by your bank and the money has been deposited to the department, your liability will not be considered resolved.
