There are two options to pay due amount

- **Credit Card**
- Check or money order (follow the payment instructions on the form or voucher associated with your filing)
- ACH Credit - ACH credit is **NOT** the preferred payment option for most taxpayers. Using this payment method requires you to directly instruct your financial institution to transfer funds from your bank account to the Department's bank account and may take 7 to 10 days to set up. 
