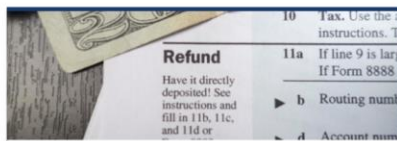
Under Payments click on **Make a Quick Pay payment**

#### How does this work?

You schedule your payment and authorize the state to take a certain amount of money from your checking or savings account using ACH Debit. The service is free.

Use this service if you make only a few payments a year. If you want to see a history of your payments, please sign up for an account on our [TAP](#) system.

#### You'll need the following information to submit a payment:

- ID [Social Security Number (SSN), Individual Taxpayer Identification Number (ITIN), Employer Identification Number (EIN)]
- First and last name or business name
- Tax type to apply the payment to (examples: income tax, sales tax)
- Email address or phone number
- Bank routing number and account number
