

MARYLAND STATE DUE PAYMENT INSTRUCTIONS

Step 1: Click on the below link

Step 2: Click on Make Credit card payment

provide the account type (checking or savings), **bank routing number** and **account number**.

To be eligible to make an **online payment via electronic funds withdrawal**, for identification purposes, the State of Maryland **must have a return on file** for the registered user.

General Payment Information

All companies collect a non-refundable, service fee for processing the credit card payment. The fee does not go to the state of Maryland. The minimum transaction amount for a credit card payment is one dollar.

Do not include the amount of the service fee as part of the tax payment.
