Online Payment

Due to a database outage from September 10, 2023, to September 11, 2023, any transaction entered through our system during that time may not have been processed. Please contact Taxpayer Services at 410-260-7980 if you think you were affected. We apologize for any inconvenience this disruption may have caused.

This system may be used to make bill payments on individual income tax liabilities using electronic funds withdrawal (direct debit / E-check) from a U.S. bank or financial institution. Foreign facilities will not be accepted.

After logging on to the Comptroller's Individual's Online Service Center you will be asked to provide the account type (checking or savings), **bank routing number** and **account number**.

To be eligible to make an **online payment via electronic funds withdrawal**, for identification purposes, the State of Maryland **must have a return on file** for the registered user.
