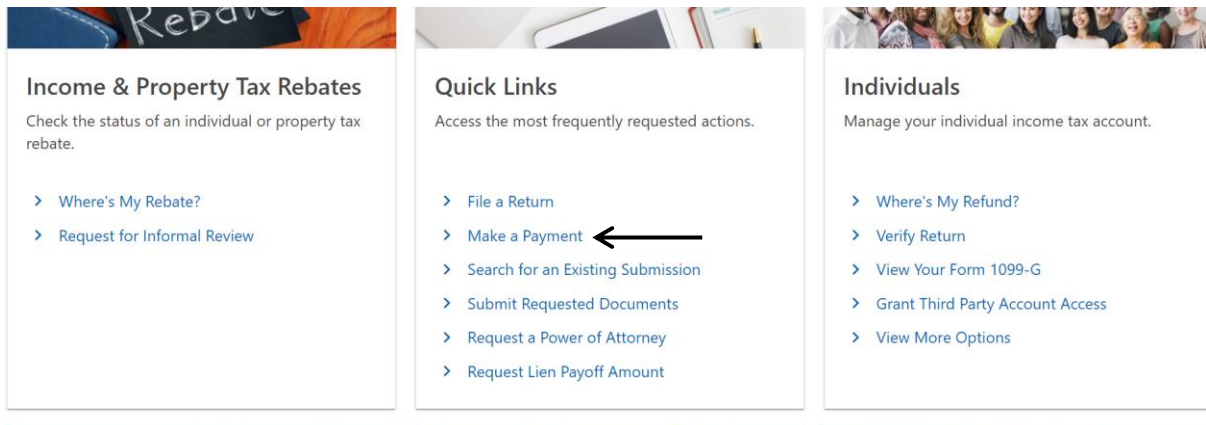

Bill Payment Pay a Statement of Account, Notice of Assessment, or account liability not associated with a return.
