- NJ-1041 - requests an extension of 5 months until 9/15/2023 to file the return.

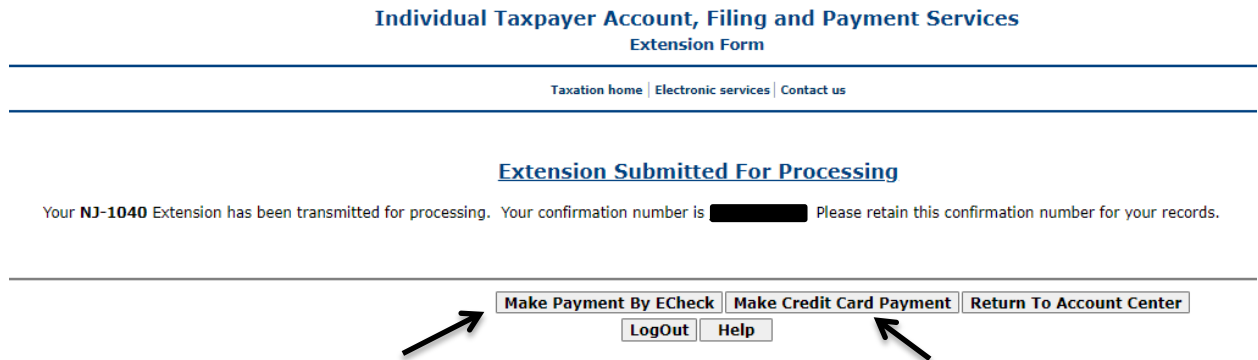
