

Steps 1:

Pay from bank account
By selecting Pay from Bank Account , the amount due will be paid with a direct debit from a checking or savings account. Please note, we will only debit the account for the amount authorized in this transaction. Monitor the bank account to verify that the payment is successful.
Pay from Bank Account
Pay by credit card or debit card
By selecting Pay by Card , the cardholder can pay the amount due by MasterCard, Visa, American Express, or Discover Card. There is a 2.20% convenience fee charged by the card service provider to cover the cost of providing this service. No part of the convenience fee goes to New York State. The payment to New York State and convenience fee will appear as two separate charges on the cardholder statement.
