Step 1:

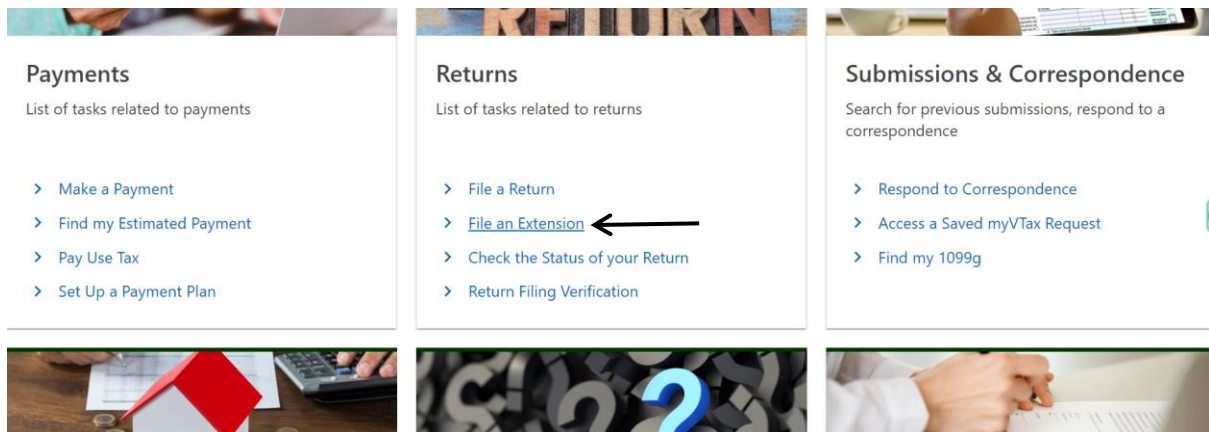

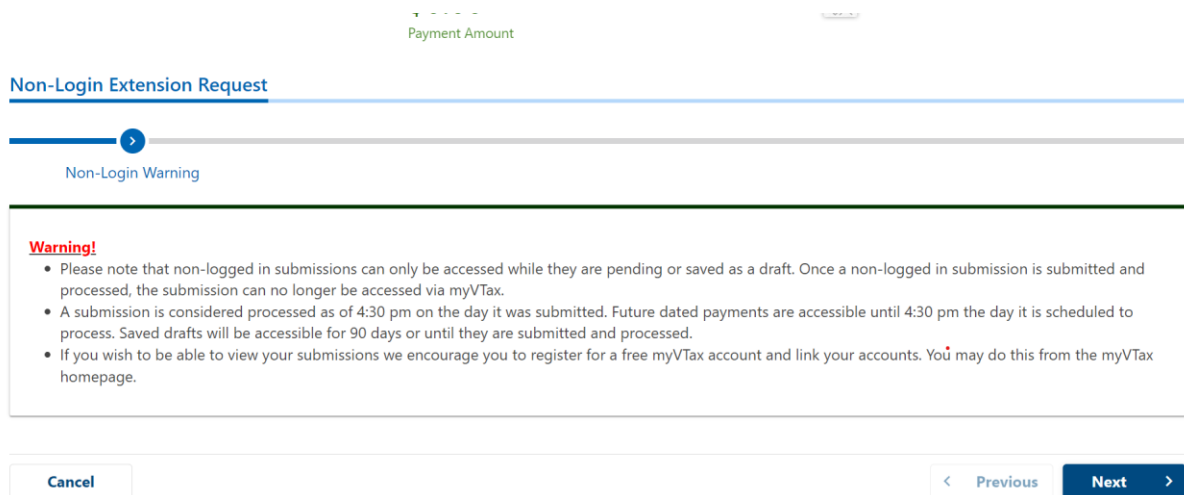
